According to the Electronic Transactions Law

The electronic signature is legally recognized and holds the same legal weight as a handwritten signature, provided it is carried out in accordance with the relevant provisions of the law and its executive regulations.

It is required that the electronic signature be linked to a digital certificate issued by a licensed certification service provider.

Additionally, **the Ministry of Justice** has specified requirements for an electronic signature to be accepted and legally effective, including its linkage to a digital certificate issued by a licensed certification service provider, and that the digital certificate must be valid at the time the signature is made.

Therefore, for an electronic signature to be legally accepted in the **Kingdom of Saudi Arabia**, it must be issued through certification service providers licensed by the **Digital Government Authority**, in compliance with the regulations and conditions outlined in the law and executive regulations.




